### Artwork Specifications

#### Submitting artwork on a zip or CD

Acceptable file formats, (Macintosh preferred), created in:

- **InDesign CS2 or below.** InDesign file, InDesign PDF file. Must include all fonts and Photoshop TIFF images used.
- **Quark 6.0 or below.** Quark file or Quark EPS. Must include all fonts and Photoshop TIFF images used.
- **Illustrator CS2 or below.** Illustrator file or Illustrator EPS or PDF files. Include Photoshop TIFF files. Please convert text to outlines to ensure proper font display. If sending native Illustrator files, all fonts and Photoshop TIFF images used must be included.
- **Photoshop CS2 or below.** All Photoshop files should be 300 dpi resolution TIFF files, 100% of final size, for both Grayscale and full color CMYK images. Full color images should be saved as CMYK. RGB files not accepted. Bitmap TIFF files should be saved at 600 dpi resolution 100% size.
- **PDF file format (Mac preferred).** All fonts MUST be embedded or converted to outlines to print correctly.
- **Please include a printout for reference.**

#### Submitting camera-ready ads

- Artwork must be submitted at 100% final size.
- **Please be aware** that business cards, brochures or any images that have been printed on a printed press do not reproduce at high quality and can create moire patterns when scanned or reprinted.

#### Please note

- For an additional fee, ads may be produced for a sponsor.
- Our graphics production department cannot modify PDF, EPS or TIFF files. Please ensure that these file types conform to our specifications in order to be press ready, otherwise additional costs may be charged.
